When you choose this option, only you can view the usernames of bidders and buyers - they're hidden from everyone else viewing your listing.

For private sellers, eBay final value fee is 10% for any item category and PayPal charges 2.9% + €0.30. It's 12.9% + €0.30 for private sellers. For business sellers, eBay final value fee starts from 6% + 20% VAT and PayPal takes 2.9% + €0.30. In total, it's (6% + (6% \* 1.2)) + 2.9% + €0.30.

You will have to pay tax on your eBay earnings if you're clearly selling items for the purposes of making a profit. How much tax do I need to pay? It all depends on how much profit you make. eBay sales should be listed right alongside all your other earnings for the year in your Self Assessment tax return, and tax is subsequently taken from your overall income (20%, 40% or 45%, depending on your tax bracket).
