Battle of the forms Related Content A battle of the forms arises when two businesses are negotiating the  
terms of a contract and each party wants to contract on the basis of its own terms. The paradigm battle of  
the forms occurs when A offers to buy goods from B on its (A's) standard terms and B purports to accept  
the offer on the basis of its own standard terms.

"Battle of the forms refers to the not uncommon situation in which one business firm makes an offer in the form of a pre-printed form contract and the offeree responds with its own form contract.
